

WIN THE ULTIMATE MAGIC EXPERIENCE WITH DYNAMO OFFICIAL RULES

Win The Ultimate Magic Experience with Dynamo Promotion begins at 19:00 p.m. GMT on March 19, 2013 (the “Promotion Start Date”) and ends at 12:00 p.m. GMT on April 30, 2013 (the “Promotion End Date”) (such period referred to herein as the “Promotion Period”). The Promotion (as defined below) consists of a contest and a sweepstakes (the “Contest” and the “Sweepstakes”, respectively, and, together, the “Promotion”). The Promotion is sponsored by Prizeo Ltd. (the “Sponsor”).

If you donate £3, you will receive 3 entries; £10, you will receive 13 entries and an exclusive unreleased clip of a Dynamo magic trick; £25, you will receive 33 entries, the exclusive unreleased clip and a signed playing card used by Dynamo; £50, you will receive 70 entries, the unreleased clip, the signed playing card and a specially printed limited edition signed photo of Dynamo; £100, you will receive 150 entries, the unreleased clip, the signed playing card, the signed photo and the Nothing Is Impossible hardcover book signed; more than £100, you will receive 150 entries, the unreleased clip, the signed playing card, the signed photo, the Nothing Is Impossible hardcover book signed and a short incoming voicemail message as an mp3 file.
